RENOVATION IN KATUPOTHA:

During our working visit in January/February, Sister Amatha mentioned that she would like to expand the home in Katupotha so more children can live there. It's a wonderful environment for children to grow up in.

While we were still calculating whether we could afford it, we received an email from a loyal donor who himself has adopted two children from Sri Lanka. He told us that he has a plot of land in Sri Lanka that he wants to sell and that he might be interested in using the money to help the foundation!

Fantastic! After a meeting with him and the board, he decided it might be a good idea to use the money to finance the expansion in Katupotha. He went to Sri Lanka a few weeks later, and together with a companion from Sri Lanka, he and Sister Amatha visited the home in Katupotha.

They reached an agreement. A drawing for an extension was made, and Sister Amatha arranged for a construction company with whom she had worked with before. The money was deposited into Sister Amatha's account, and construction was started on August 12th. It's really going fast! We are kept informed and receive many photos. On his return, we held another meeting with the donor and he told us all about his visit. He was truly impressed with Sister Amatha and the work she does.

We are very grateful to him for this wonderful initiative!
